American Electric Power Service Corporation, on behalf of its affiliate, Transource Pennsylvania, LLC (“Transource Pennsylvania”), hereby submits for filing for informational purposes Transource Pennsylvania’s 2022 Projected Transmission Revenue Requirement (“PTRR”). Service of the PTRR is being provided to PJM members via the PJM listserv. A copy of this notice of posting will be provided to PJM, PJM customers, and the parties in this docket, and to all affected state commissions. The PTRR provides the calculation of the 2022 projected revenue requirement and includes the True-up amount calculated in Pennsylvania’s 2020 Annual True-up. The 2022 projected revenue requirement will be included in customer rates beginning January 1, 2022. The PTRR contains no expenses or costs that have been alleged or judged in any administrative or judicial proceeding to be illegal, duplicative, or unnecessary costs that are demonstrably the product of discriminatory employment practices, as defined in 18 C.F.R. § 35.13(b)(7). In addition, Transource Pennsylvania has not made any material changes in its accounting policies and practices from those in effect during the previous rate year and upon which the current rate is based.

Transource Pennsylvania will host a webinar and teleconference meeting at 3:00 p.m. (Eastern Standard Time) on November 4, 2021, to afford interested parties the opportunity to discuss the PTRR.
