RE: Pre-Qualification Confirmation for Designated Entity Status (ID 13-06)

Dear Mr. Liu:

In accordance with Section 2.1 of PJM Manual 14F: Competitive Planning Process, LS Power Associates, L.P. and its affiliates ("LS Power Group", also known as "LS Power") confirm the pre-qualification information submitted on July 16, 2018 remains valid, with the following updates.

Section 2

LS Power Grid Mid-Atlantic, LLC was formed in January 2021 as an additional wholly-owned LS Power affiliate and subsidiary to pursue independent transmission within the PJM area, in addition to the other affiliates of LS Power Group such as Central Transmission and Silver Run Electric.

Republic Transmission, LLC, DesertLink, LLC, and Silver Run Electric, LLC each placed their facilities in service during 2020. Each entity completed construction prior to the required in-service date and at a cost less than its cost commitment proposal.

Two additional subsidiaries of LS Power Associates, L.P. have been selected under three competitive transmission processes, two by the California Independent System Operator and one by the New York Independent System Operator.


